## Hotel Equities Names New GM for Residence Inn Miami Beach/Surfside

Under his watch, the hotel became a consistent RevPAR leader and Mr. Holman captured the firm's Rising Star and Chairman's Circle awards for his leadership skills and financial success.

In 2000, Lodging Dynamics Hospitality Group hired Mr. Holman as General Manager for the Residence Inn by Marriott in Salt Lake City, Utah. During his tenure, he spearheaded a complete renovation of the property including the conversion and addition of a 60-room independent hotel as an extension of the Residence Inn. He enhanced guest and associate satisfaction, increased the hotel's profitability and hosted the U.S. Olympic Committee during the 2002 Winter Olympic Games before his promotion to VP of Operations for the firm.

Mr. Holman earned a B.S. in Business Management with an emphasis in finance from Brigham Young University.
